DECEMBER

STEP 12

"Having had a spiritual awakening as the result of these Steps, we tried to carry this message to alcoholics, and to practice these principles in all our affairs."

If we have made an honest effort to work all 12 Steps, we are promised a spiritual awakening. Members of AA who have worked the 12 Steps often talk of feeling free, new, lighthearted and they also spend more of their time caring about others rather than on their self-obsession. On a daily basis we now have the opportunity to put into practice things that we are finally in possession of: a degree of honesty, forgiveness, tolerance, unselfishness, peace of mind and love.

Practicing the 12 steps in all our affairs includes turning our thinking and actions over to a Higher Power, making amends, sharing our experience, strength and hope, and giving back by staying active in service one day at a time....for the rest of our life. The increasing ability to step outside of ourselves and to fully participate in life is just one of the many amazing gifts of the 12 Steps. It's fascinating how change happens and we grow daily, little by little in incremental steps. Life events, people and challenges are easier to deal with as we practice the spiritual principles in all our affairs of our daily lives.

The first part of Step 12—to carry this message to alcoholics—relies on the second part—to practice these principles in all our affairs. Someone who doesn't live all 12 steps, to the best of their ability, often sees no need to help others. It's not enough for us to simply complete the 12 steps as a way to check boxes if we don't internalize the spiritual principles and practice them on a daily basis we have missed the whole point. When we do live by the spiritual principles we discover a way of living that we never imagined was possible and we gain an inner strength we never knew existed. Step 12 admonishes members to put the spiritual growth they have found to work not only within the AA fellowship, but it all aspects of their lives—to practice these principles in ALL our affairs.

I am responsible. When anyone, anywhere, reaches out for help, I want the hand of AA always to be there. And for that I am responsible. As the history of AA so clearly indicates, it was working with other alcoholics that kept Bill W. and Dr. Bob sober when all else failed. The same principle is true for all AA members: in order to keep it, we have to give it away. Carrying the message to others, by sharing experience, strength, and hope, reinforces the spiritual principle of the twelve steps in the person being 12th-stepped as well as the one doing the sharing. If nobody was doing any 12th-step work, the program would simply cease to exist. Without the service work of those who came before, no members would be here now.

Bill W. has boundless praise for the final step: "Practically every A.A. member declares that no satisfaction has been deeper and no joy greater than in a Twelfth Step job well done." What's the secret to unlocking this sense of gratification and contentment? The power of Step 12 rests in the age-old saying that it's far better to give than to receive. The world says happiness comes when other people give us things—love, gifts, money, attention. A.A. members who practice all 12 Steps

usually find the opposite to be true. When they give back to others, they overcome their own selfimposed isolation. They build new relationships based on selfless caring and in doing so, they expand their hearts and souls. How true it is that, "life will take on new meaning.

To watch people recover, to see them help others, to watch loneliness vanish, to see a fellowship grow up about you, to have a host of friends - this is an experience you must not miss. We know you will not want to miss it. Frequent contact with newcomers and with each other is the bright spot of our lives."

TRADITION 12

"We of Alcoholics Anonymous believe that the principle of Anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him Who presides over us all."

I love the definition of contemplation which is, "concentration on spiritual things, a state of mystical awareness of God's being, an act of considering with attention," which is exactly what the program of AA has brought into my life.

"Tradition Twelve in the Long Form is one of the most beautiful expressions of what we aspire to be in all of our literature. It asks that I place principles ahead of my own defective, self-concerned character through the practice of the Twelve Steps as an individual and the Twelve Traditions as a member of the fellowship to ensure unity with God and the world around me as I seek to live in my primary purpose of service. It also reminds me that I need to remember that it is God who makes these blessings possible, and that I express my gratitude by carrying the AA message to others, as outlined in the Big Book as a member and through participating in the fellowship in a group which adheres to the Traditions and hence, the preservation of our unity. Again, of maximum service to God and my fellows. I never cease to be amazed at the wondrous work that God has wrought through our Three Legacies of Unity, Service, and Recovery."

We practice this tradition for several reasons; to protect AA from ourselves, to practice genuine humility and to always keep gratitude in our lives. Giving up is an essential idea of Tradition 12 and the individual or group is asked to give up something for the welfare of the group—we givw up our way. Tradition 12 stresses an attitude of humble anonymity and it includes all proceeding 11 Traditions.

Unfortunately, the tradition of anonymity is increasingly being challenged by AA members aspiring to be public examples of recovery or advocates for "ending the stigma." While I'm sure most are well-meaning individuals with good motives ignoring anonymity, as outlined by Tradition 11 and 12, shows a complete lack of understanding and respect for the program of AA. Although this Tradition was born out of early AA's fears of public distrust and fear of being overrun by too many requests for help, time has proven that the initial instinct to maintain anonymity in AA was a wise one. For many, the temptation to share the program through self-promotion, publishing books, public testimonials and media appearances have proved to be disastrous for the individual and harmful to AA. It is also dangerous when members take it upon themselves to speak inside the rooms of AA as an authority on outside issues, including using speaking opportunities to offer personal opinions. Groups also suffer when self-appointed leaders dominate groups or AA as a whole. It has become very clear that anonymity is not just a good practical idea, but rather it is spiritually vital for the individual and AA as a whole.

Keep in mind that AA is not a secret society (Dr. Bob encouraged the use of full names in AA meetings), but on the flipside it is also not a personal talk show platform either and anonymity is the tradition that safeguards the humility of our fellowship. The wonderful aspect of Tradition 12 is that it gives equal credence to the contribution and participation of every single member and it directs us to practice humility in our AA work and not care who gets the credit.

Tradition 12 also means that the principles of the 12-step program should be put first, rather than personal opinion and to practice spiritual principles before inserting our own personality. The spiritual principles are AA's foundation and are our guide; rather than just what is convenient at the moment, what is popular or our personal opinions. Both as members and as the fellowship, we need to humbly acknowledge our dependence on a Power greater than ourselves to lovingly guide us in all our affairs. Practicing genuine humility is often difficult because it means when we walk into a meeting we leave "our way" at the door. Whether rich or poor, race, religion, young or old, gender, our education, or the level of success, none of it has bearing on what we can get from or what we can contribute to the AA program.

It is humility that makes space for the love of neighbor. In the absence of humility, the self takes up all the available space in the room of being and no other person can fit into it. In humility love makes space for others as equally regarded by a loving God. In this shift from relating to others purely to the extent that they contribute to selfish agendas, the self finds freedom. Humility then is freedom from the falsehood and delusion of placing self at the center of the universe. As Bill W. saw it, to recover requires the alcoholic "to gain a vision of humility as the avenue to true freedom of the human spirit"

CONCEPT 12

"General Warranties of the Conference: in all its proceedings, the General Service Conference shall observe the spirit of the A.A. Tradition, taking great care that (1) the Conference never becomes the seat of perilous wealth or power; that (2) sufficient operating funds, plus an ample reserve, be its prudent financial principle; that (3) none of the Conference Members shall ever be placed in a position of unqualified authority over any of the others; that (4) all important decisions be reached by discussion, vote, and, whenever possible, by substantial unanimity; that (5) no Conference action ever be personally punitive or an incitement to public controversy; that, though the (6) Conference may act for the service of Alcoholics Anonymous, it shall never perform any acts of government; and that, like the Society of Alcoholics Anonymous which it serves, the Conference itself will always remain democratic in thought and action."

This final concept has been called "The A.A. Service Bill of Rights" and also goes by the name "The 6 Warranties." It is designed to protect us from ourselves and it gives us a standard by which we respect each other's spiritual liberties. It also protects us from errors with money, property, prestige, and power; through the principles, attitudes of unity, and a spirit of prudence.

How important is Concept 12? Well it ensures that we are guaranteed the freedom of selfless service...provided we observe them. In setting up the structure of AA, Bill W. left the door open for all kinds of alterations and changes for all the other eleven Concepts (as well as the rest of the Conference Charter) and they all can be easily amended except for Concept 12—it can only be changed by "written consent of ¾ of all A.A. groups." Not just the AA groups in American—it must be ¾ of the AA groups in the world!

Why? Because, Bill W. believe that these Warranties in Concept 12 indicate the spirituality which the Conference should always possess. Interestingly, this is also true to change the Twelve Steps and the Twelve Traditions.

If followed, the Warranties keep us from the extremes of fear and recklessness, through the practice of prudence. Bill W., who knew it was vital to the survival of AA, often wrote about the importance of prudence in achieving harmony, effectiveness, and consistent spiritual progress. In AA, prudence is a workable middle ground, it is a channel of clear sailing between the obstacles of fear on the one side and of recklessness on the other. In practice, prudence is the only way in which harmony, effectiveness, and consistent spiritual progress can be achieved and the Warranties provide us with protection against needless errors, against ourselves and our temptations to wealth, prestige, power, etc.

In short, the Warranties state that;

- 1. We do not pursue authority, wealth, and power.
- 2. We live by a prudent financial principle: sufficient operating funds plus an ample reserve (one year of operating expenses).
- 3. We are not dictators and are not placed in a position of unqualified authority over anyone.
- 4. We seek substantial unanimity whenever possible.
- 5. We are not personally punitive, nor do we incite public controversy.
- 6. We are democratic in thought and action.

The Warranties also express spiritual principles which apply to all other A.A. entities as well.

Warranty One:

"The Conference shall never become the seat of perilous wealth or power." Spiritual Principle: Selflessness. The Seventh Tradition protects us against the accumulation of too much money. So long as we refuse to take outside contributions and limit individual member's donations, "we shall not become wealthy in any perilous sense." And if we live by Tradition Two — that "our ultimate authority is a loving God" and that "our leaders are but trusted servants; they do not govern" — then we are safe from perilous power.

Warranty Two:

"Sufficient operating funds, plus an ample Reserve, should be its prudent financial principle." Spiritual Principle: Realism. Although many of us as active alcoholics were free spenders, when it comes to putting more than a dollar in the basket, we all of a sudden get stingy. Thankfully the cost of the service office is relatively low in terms of the number of groups served, and hopefully if sponsors and home groups explain where the support goes people will give. The Reserve Fund in AA, should only be one full year's operating expenses of the G.S.O. and the Grapevine (likewise for groups). From what I have learned, the Reserve Fund is made up almost entirely from income from the sale of A.A. literature, which also is used to make up the deficit between group contributions and the cost of group services.

Warranty Three:

"None of the Conference members shall ever be placed in a position of unqualified authority over any of the others." Spiritual Principle: Representation. This principle is discussed earlier in Concept IV, but it is so important that it was made the subject of this Warranty. AA has a strong stand against the creation of unqualified authority at any point in our Conference structure.

Warranty Four:

"That all important decisions should be reached by discussion, vote, and wherever possible, by substantial unanimity." Spiritual Principle: Dialogue. This Warranty is, on the one hand, a safeguard against any hasty or overbearing authority of a simple majority; and, on the other hand, it takes notice of the rights and the frequent wisdom of minorities, however small. This principle

guarantees that all matters of importance, time permitting, will be extensively debated, and that such debates will continue until a really heavy majority can support every critical decision.

Warranty Five:

"That no Conference action shall ever be personally punitive or an incitement to public controversy." Spiritual Principle: Compassion. Although practically all other societies and governments find it necessary to punish individual members for violations of their beliefs, principles or laws, Alcoholics Anonymous finds this practice unnecessary. Why? When we fail to follow sound spiritual principles, alcohol cuts us down and no humanly administered system of penalties is needed. This actually is an enormous advantage to us all, and one which we should never abandon by resorting to personal attack and punishment. It is vital to AA that this spiritual principle be practiced at the individual and group level as well. Of all society, AA can least afford to risk the resentments and conflicts which would result were we ever to yield to the temptation to punish in anger. We cannot and should not enter into public controversy, even in self-defense. Our experience has shown that AA must cease to fight or quarrel with anyone, no matter what the provocation. Nothing could be more damaging to our unity, and to the worldwide goodwill which A.A. enjoys, than public controversy, no matter how promising the immediate outcome may appear. It is very difficult to practice, but even when A.A. comes under sharp public attack or heavy ridicule (especially when we do not deserve it) AA's defense is no defense whatever—complete and total silence at the public level. On the other hand, if the criticism of A.A. is partly or wholly justified, it is important to acknowledge this privately to the critics (also with our thanks to them) and make amends quickly. Regarding public violations of A.A. Traditions by our very own members, or when people try to use the A.A. name for their private purposes, any aggressive or punitive action must be omitted from our actions. Privately, we can and should inform Tradition-violators that they are out of line with the Traditions, however in the long run we have to rely mainly on the pressures of A.A. opinion, strong sponsorship and the discipline we all get from alcohol.

Warranty Six:

"That though the Conference may act for the service of Alcoholics Anonymous, it shall never perform any acts of government; and that, like the Society of Alcoholics Anonymous which it serves, the Conference itself will always remain democratic in thought and action." Spiritual Principle: Respect. The A.A. Traditions give the individual member and the A.A. group extraordinary liberties. In fact, we in A.A. probably enjoy more and greater freedoms than any Fellowship in the world. This as no virtue, in fact quite the opposite, it is self-preservation. We know we have to choose conformity to A.A.'s Twelve Steps and Twelve Traditions or else we will face destruction and death. Because we set such a high value on our great liberties and cannot conceive that they will need to be limited, the General Service Conference is to abstain completely from any and all acts of authoritative government which could in any way curtail A.A.'s freedom as a spiritual entity. We as AA members, expect our Conference to always act in the spirit of mutual respect and love; one member to another.

By following the Twelve Concepts personally, in our home-groups, in our various service positions and collectively in our World Service affairs, our fellowship is assured that we can effectively carry AA's message of hope to the still-suffering alcoholic throughout our service structure, while maintaining a spirit of love, trust, cooperation and unity.
